10 Clackmannanshire Councillor Reports

Cllr Donald Balsillie

Local Development Plan - This has been approved by the Scottish Government including approx. 430 houses at Alva West although the usual planning procedures will apply. A Community Councillor asked if a more detailed study had been completed Scottish Environment Protection Agency (SEPA) to address concerns about drainage. Cllr Balsillie said drainage issues will be addressed.

Land at Berryfield (a.k.a. site of former Hodgsons mill, East Stirling St). Cllr Balsillie confirmed that Alva Investments Ltd paid £2m for this site which has planning permission for housing. Current owners are trying to sell it. In due course this land could be subject to the provisions of the new Community Land Act. **Land at Former Alva Academy** - Cllr Balsille explained work on the eco-housing at Erskine Street/Queen Street is scheduled to commence soon.

Former Alva Glen Hotel Site - No planning application received yet.

ACC letters to landowners - Following discussion it was agreed that ACC will write to the owners of the land at the former Alva Glen Hotel site and also the land at Berryfield to ask what they intend doing with the land.

Leisure Centre (OLC) - Cllr Balsille confimed tenders are out for demolition and work should commence June/July.

Pigeons - Cllr Balsillie explained the traps on the roof of Ochil Leisure Centre were not very successful; they caught less than 100 birds. The traps have been moved. There are apparently still people feeding the pigeons and there is nothing to prevent them from doing so but this encourages the pigeons to remain where there is a source of food. A Community Councillor reported that a pigeon had entered a shop and food valued at £80 had to be destroyed.

Buses to Forth Valley Royal Hospital, Larbert – From today First Bus have the contract for buses to the hospital to 2018. Buses (H1 and H2) don't operate on Sundays.

Alva Academy - Cllr Balsillie reported that the new set of performance measures introduced by Scottish Government only counts S5 and S6 so figures will not reflect reality as S4 isn't included.

Fracking - Clackmannanshire Council (CC) have invited Cluff Natural Resources Ltd to give a presentation on the underground coal gasification process to a Members Briefing on 29 April. CC are taking advice on potential health and ethical issues. A MOP expressed concern that CC have extended this invitation to Cluff as considers such companies move on when they are finished leaving communities to deal with the consequences.

Report to Alva Community Council - 13 April 2015

The past month has been relatively quiet perhaps something to do with the school holidays.

However there have been two meetings where matters of interest have been addressed.

The Housing, Health and Social Care Committee met on 2 April and the following Alva related issues were on the agenda.

Development of former Alva Academy Site.

The grant offer to the developer and Link Housing Association has been finalised and all legalities almost concluded. It is expected that work will start on site shortly and, once underway will provide 48 'greener homes'.

The delay arises from the non traditional model of building the houses off site which requires finance "up front" and this is not the government norm.

FalkirkPension Fund Investment.

As the council's representative on the Falkirk Pension Fund I am pleased to report that the fund has become the first to invest a small part of its £1.5 billion portfolio in social housing and, by way of bonus, here in Central Scotland.

The Scottish Government has added to this investment and Clackmannanshire's initial share will be some 35 homes to be developed with Castle Rock Edinvar Housing Association.

The site identified for the pension units is currently Sauchie West. It may be preferable to choose another site which can be delivered more quickly, so it is possible that these units will move to an alternative site listed in the programme/shadow programme.

Alva West is one of seven sites in the shadow programme which records, *Alva West: This large site* (12.61ha) is identified in the local plan as a longer term development area. It will be developed, if required, once significant progress has been made in the development of the brownfield sites. Developer contributions are likely to include affordable housing provision."

Home Energy Efficiency Programme

Properties in Alva at 34 - 59 The Nebit; 12 - 68 Craighorn Road and 49 - 55 St Serfs Walk are included in the 2015/16 funding bid for external wall and top-up loft insulation. These 52 properties are non traditional timber houses, 52 Properties (34 Owner Occupiers and 18 Council Tenants.

A special council meeting was held on 26 March to consider and determine three property transactions and, while none of these is in Alva, I think two of them will be of local interest.

Greenfield House, Alloa.

The recently vacated council office was advertised for sale and attracted a number of offers. The council selected the offer from a private sector company who will develop the house into a number of flats providing supported/sheltered accommodation.

This will also provide up to 25 new jobs and was considered to be the option most appropriate for an iconic building set in the public park.

Former Co-op site, Primrose Street, Alloa

The council decided to purchase this site with the support of a substantial grant from Scottish government. A development brief is to be worked up and the aim is to provide social housing with ground floor retail space.

Former Claremont Primary Site

Probably of less local interets, the council accepted an unconditional offer from Barrat Ltd who are currently nearing completion of the development of the adjacent site of the former Alloa Academy.

Since your last meeting on 09/02/2015 we have recorded 30 crimes and offences that occurred in Alva as follows;

- 13 Undetected Crimes
- 14 Detected Crimes
- 2 V-RECS

Detected

For the last few months a large number of crime reports have been recorded regarding Housebreakings, Thefts and Theft OLP in the Alva area. The Community Investigation Unit were able to identify a suspect from CCTV who was subsequently reported to the Procurator Fiscal for 11 crimes using the Howden Principle as a result of the similar MO.

A search warrant was craved by Police for an address in Caroline Crescent where a male and female have now been reported for Concerned in the Supply of a Class B drug.

A female was arrested and charged with a Vandalism. Threatening and

Crime Reports

A male and female were reported to the Procurator Fiscal for possession of Class A and B drugs found within an address at The Nebit.

Three assaults to injury at Greenhead and a male and female were arrested and charged.

As a result of proactive patrols in the Alva area Police traced a male within the Cochrane Park in possession on a Class B drug.

Threatening and abusive behaviour (Domestic) at Strude Mill, male arrested for offence.

Domestic Assault at Brook Street where one male was arrested for offence.

Theft by Shoplifting at the Coop where a male has been identified and will be reported to the Procurator Fiscal.

One male reported for numerous road traffic offences including no licence, insurance and MOT.

Theft by Housebreaking at an address in Torry Drive where two bikes were stolen from an insecure garage. Enquiry is ongoing at this time to identify suspect.

Theft of money from an address in Johnstone Street and a female has been spoken to regarding same however further enquiry is to be carried out by officers dealing.

Theft of purse from and address in Craighorn Road. Complainer has identified the male responsible who is yet to be traced and spoken to by Police.

Sneak in Theft from an address in Johnstone Street where access has been gained to an insecure door to the property and a mobile phone, bike and car keys have been stolen. Further enquiry ongoing as theft may be related to the series of housebreakings in the area.

Theft of purse from the Crown Inn licensed premises. Suspect is a female who is yet to be identified from CCTV.

Taxi damaged in Stirling Street where the driver believed an air rifle was fired at the car causing damage – enquiry ongoing with CCTV

Window smashed at The Wynd. A group of youths are suspected to be responsible and one male youth has been named and yet to be interviewed regarding damage.

Car damaged in Queen Street where the roof and bonnet was scratched by a sharp implement.

Assault

Male assaulted by two unknown males near to Viewfield Drive – enquiry ongoing to identify suspects

Male seriously assaulted by another male at a party within an address in Minto Garden. Enquiries are ongoing to identify the male responsible.

Other crimes of note;

Taxi fraud, where a male has failed to pay his fare once taken to Dalmore Drive. Enquiry ongoing to identify the male responsible from CCTV.
