The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Queen Street, Alva) (Temporary Road Closure) Order 2017" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 22<sup>nd</sup> January 2018 and will remain in operation until 1700 hours on Sunday 18<sup>th</sup> February 2018.
2. The effect of this Order shall be to close to vehicles:-

The period from 0800 hours on Monday 22<sup>nd</sup> January 2018 until 1700 hours on Sunday 18<sup>th</sup> February 2018, on the section of roads described in Schedule. The temporary closure is necessary to allow excavation for new gas, electric and water mains. Pedestrian access will be retained.

The Council has made "The Clackmannanshire Council (Queen Street, Alva) (Temporary Road Closure) Order 2017, under the Road Traffic Regulation Act 1984 (as amended) on 18<sup>th</sup> December 2017: to close to vehicles the section of road at **Queen Street, Alva** - from its junction with Beauclerc Street southwards until its junction with Park Street, a distance of 145 metres or thereby). Alternative Route: Via Stirling Street, Brook Street, Beauclerc Street and vice versa. The order runs from 0800 hours on Monday 22<sup>nd</sup> January 2018 until 1700 hours on Sunday 18<sup>th</sup> February 2018. The works are necessary to allow excavation for new gas, electric and water mains. Pedestrian access will be retained. 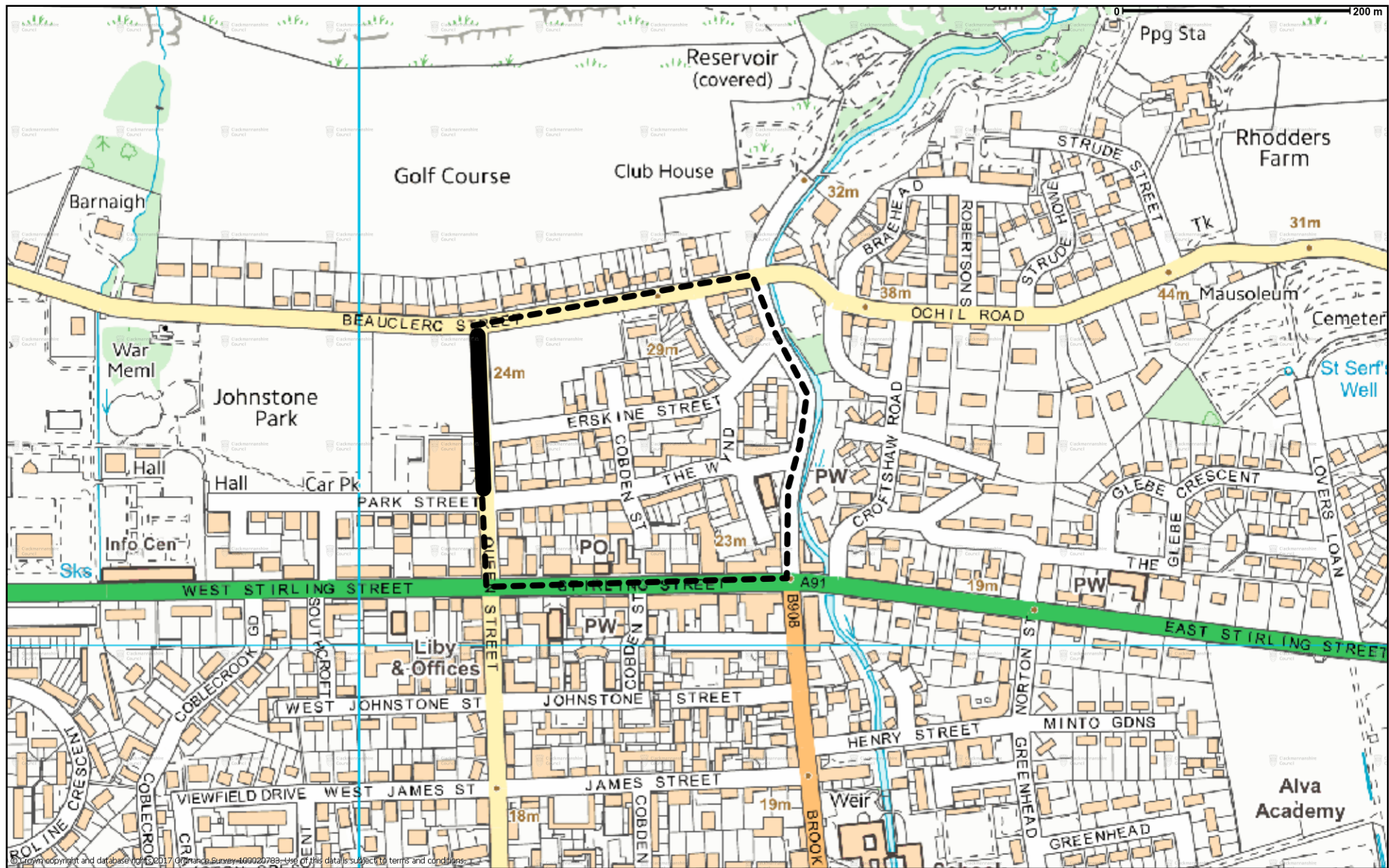
